

### **Type 1 Summit survey giveaway**

1. These terms and conditions (Terms) of entry, including information on how to participate and prize details, apply to the promotion and entry into the promotion is deemed acceptance of these Terms.
2. The promoter is JDRF Australia (ACN 002 286 553, ABN 40 002 286 553, DGR 042 753).
